### SCOPE AND TYPE

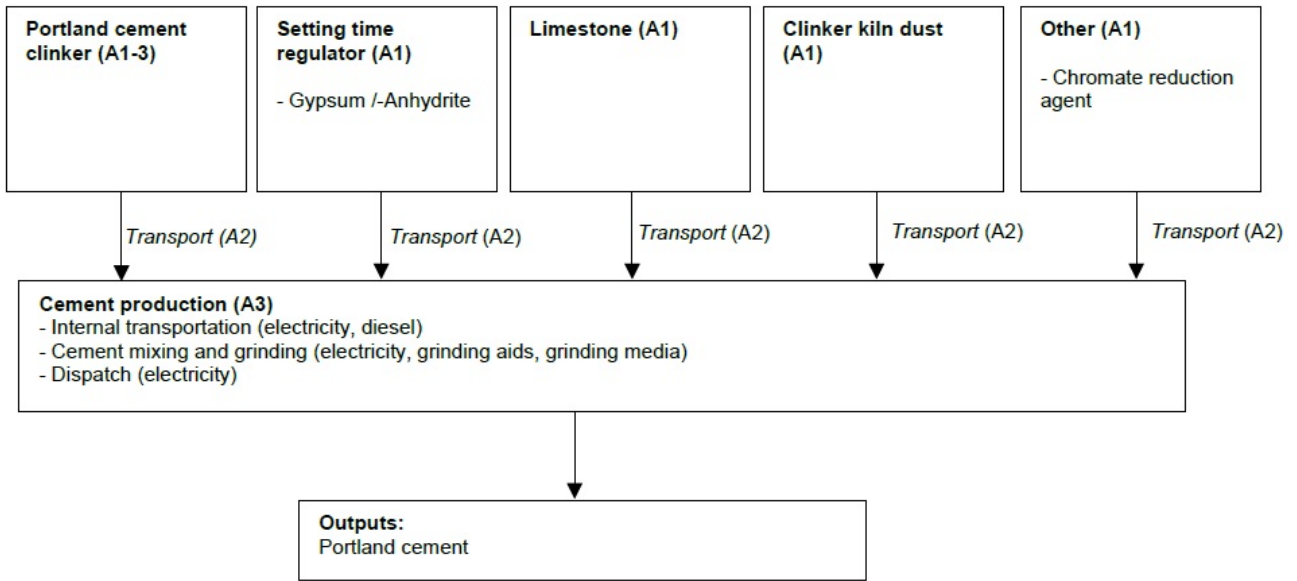
Cement is a hydraulic binder, mainly used for concrete, mortar and cement screed. Since it is semi-finished product, in this EPD only the product stage is included.

## **CALCULATION RULES**

Virtually no materials or processes have been excluded from the study (cut-of rule is well below 1%). Refractories, grinding media and grinding aids are included.

Primary data at the production locations of HeidelbergCement where collected in 2019-2020 from base year 2018.

The “production” of secondary fuels and materials is allocated to the previous life cycle. Transportation to the production site of heidelbergCement is allocated to the production of cement. Also, the emissions from the combustion of secondary fuels for clinker production are allocated to the cement production. Biogenic CO<sub>2</sub> emissions are not included.

The LCA calculations are made using the Ecoinvent database v3.4. Infrastructure processes in Ecoinvent processes have been included, long term emissions in Ecoinvent processes have been excluded from the LCA calculations.

## **SCENARIOS AND ADDITIONAL TECHNICAL INFORMATION**

*Module A1:*

This module includes the supply of raw materials and fuels.

*Module A2:*

This module includes the transport of raw materials and fuels to the cement plant.

*Module A3:*

This module includes the grinding of the raw materials, the production of the clinker and the processing and blending of the cement constituents.

## **DECLARATION OF SVHC**
