DETAILED PRODUCT DESCRIPTION

The main advantage of the SolidScreen Niche XS is that the headbox is integrated into the facade and thus hidden from sight. The bottom slat is out of sight when the screen is rolled up. Thanks to the additional funnel side guide, the bottom slat runs smoothly into the headbox. With the SolidScreen Niche XS, the facade retains a sleek look, whether the screen is open or closed. The SolidScreen Niche XS can also withstand wind speeds up to 145 km/h (12 Beaufort). Repair or replacement of the SolidScreen Niche XS can be done quickly and easily. The side guide consists of 3 profiles and is easy to disassemble, giving convenient access from the underside to the roller and fabric. The SolidScreen Niche XS is often used in projects.

Fabric

The SolidScreen Niche XS is always made with Tibelly screenfabric with zipper. A zipped screen fabric is provided with an upper and lower hem of 3.5 cm for the cord. These are thermally welded. The sides of a zipped screen fabric are provided with zippers attached by means high frequency welding. Hylas applies the SLIM-ZIPP as standard. The zipper of the innovative SLIM-ZIPP is considerably thinner than the band previously used. This allows us to weld the zipper completely into the screen fabric during the manufacturing process. This results in a thinner roll diameter which results in a nicer hanging appearance.


