### DETAILED PRODUCT DESCRIPTION

Ecocem Superfine ggbs is a (latent) hydraulic binder made by finely grinding granulated blastfurnace slag (GGBS). Ecocem ggbs is an “intermediate” product, i.e., a constituent to produce concrete, as well as mortar, masonry mortar, and other cement bound materials.

Ecocem ground granulated slag is manufactured under a fully controlled process, by drying and fine grinding the raw material, granulated slag. This is a secondary material co-produced with pig iron by the blast furnaces of ArcelorMittal.

It is used:

- In concrete mixes as a substitute for cements, as a type II pozzolanic or latent hydraulic additive or as a grain modifier; Concrete producers determine the proportions of binders used (ordinary cement and Ecocem ggbs), so they are able to apply the optimal mix. This means that the use of Ecocem ggbs will vary with the intended application and requirements of the final concrete product
- In the mix for cement surface preparations.
- With bentonite for producing special foundations, soil reinforcements, etc.
- As a base for hydraulic binders for roads or for road gravel.
- For treating agricultural materials (hemp, rapeseed, etc.) to improve their resistance to water penetration, mildew, and their reaction to fire.
- In combination with marine sediments.

Besides producing Ecocem (GGBS), Ecocem Ireland also produces Ecocem Superfine and different mixes of Ecocem and Portland cement.

Ecocem superfine is a finer grade of Ground granulated blastfurnace slag (GGBS).

Ecocem CEM III/A contains up to 65% GGBS.

Ecocem CEM III/C contains up to 95% GGBS.

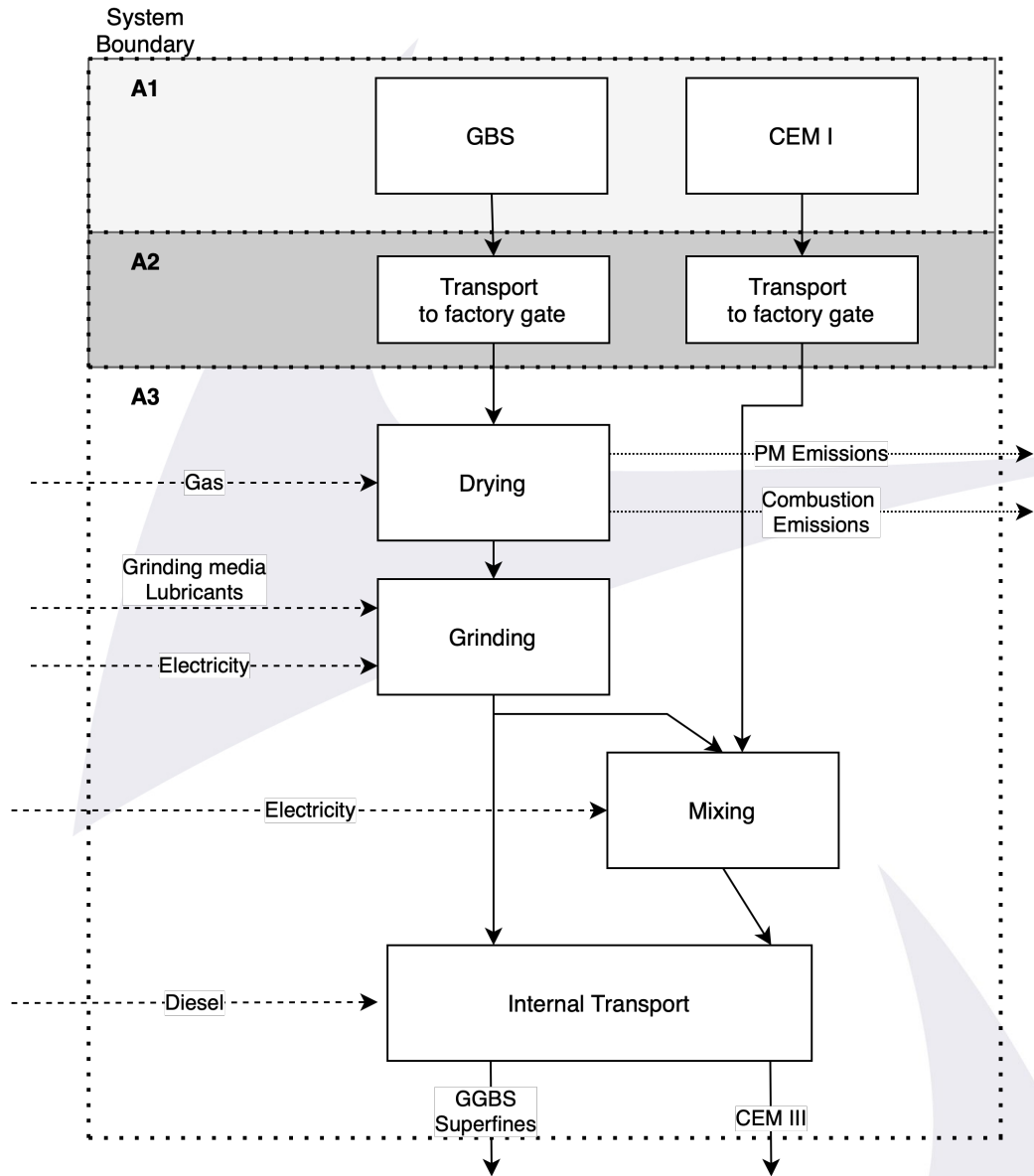
### SCOPE AND TYPE

The type of this EPD is Cradle-to-Gate (A1-A3). All major steps from the extraction of natural resources to the factory gate are included in the environmental performance of the manufacturing phase, except those that are not relevant to the environmental performance of the product. The software SimaPro is used to perform the LCA. The background databases used is EcoInvent 3.6

## CALCULATION RULES

### *Data quality*

Data flows have been modeled as realistically as possible. Data quality assessment is based on the principle that the primary data used for processes occurring at the production site is selected in the first instance. Where this is not available, other reference data is selected from appropriate sources.

### *Data collection period*

The dataset is representative for the production processes used in 2021.

### *Methodology and reproducibility*

The process descriptions and quantities in this study are reproducible in accordance to the reference standards that have been used. The references of all sources, both primary and public sources and literature, have been documented. In addition, to facilitate the reproducibility of this LCA, a full set of data records has been generated.

### *Allocation*

The impacts related to the quenching of the blast furnace slag are allocated onto the Ecocem production, no further impacts of steel production are allocated to the blast furnace slag.

## SCENARIOS AND ADDITIONAL TECHNICAL INFORMATION

### *A1. Raw materials supply*

This module considers the extraction and processing of GBS. The system boundary of the raw material production is determined between the blast furnace slag production and the quenching process. The impacts related to the quenching of the blast furnace slag are allocated onto the Ecocem production.

### *A2. Transport of raw materials to manufacturer*

The transportation of the suppliers to Ecocem Dublin is done by truck or Ship.

### *A3. Manufacturing*

The production consists of grinding and drying of Granulated Blastfurnace Slag (GBS).



### DECLARATION OF SVHC

None of the substances contained in the product are listed in the “Candidate List of Substances of Very High Concern for authorisation”, or they do not exceed the threshold with the European Chemicals Agency.
