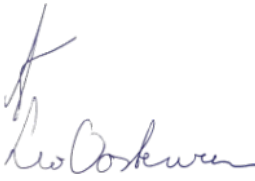

DETAILED PRODUCT DESCRIPTION

The ThermoPlus coating is used as an indoor water-based wall coating for climate control. Aside from the aesthetic goal of wall paint, the goal is to reduce energy use by controlling the temperature of indoor spaces, and to optimize their humidity. ThermoPlus is prepared in the SICC facility in Berlin, where the ingredients are mixed, dispersed and packaged in 12,5L plastic containers. The reference service life is 20 years.

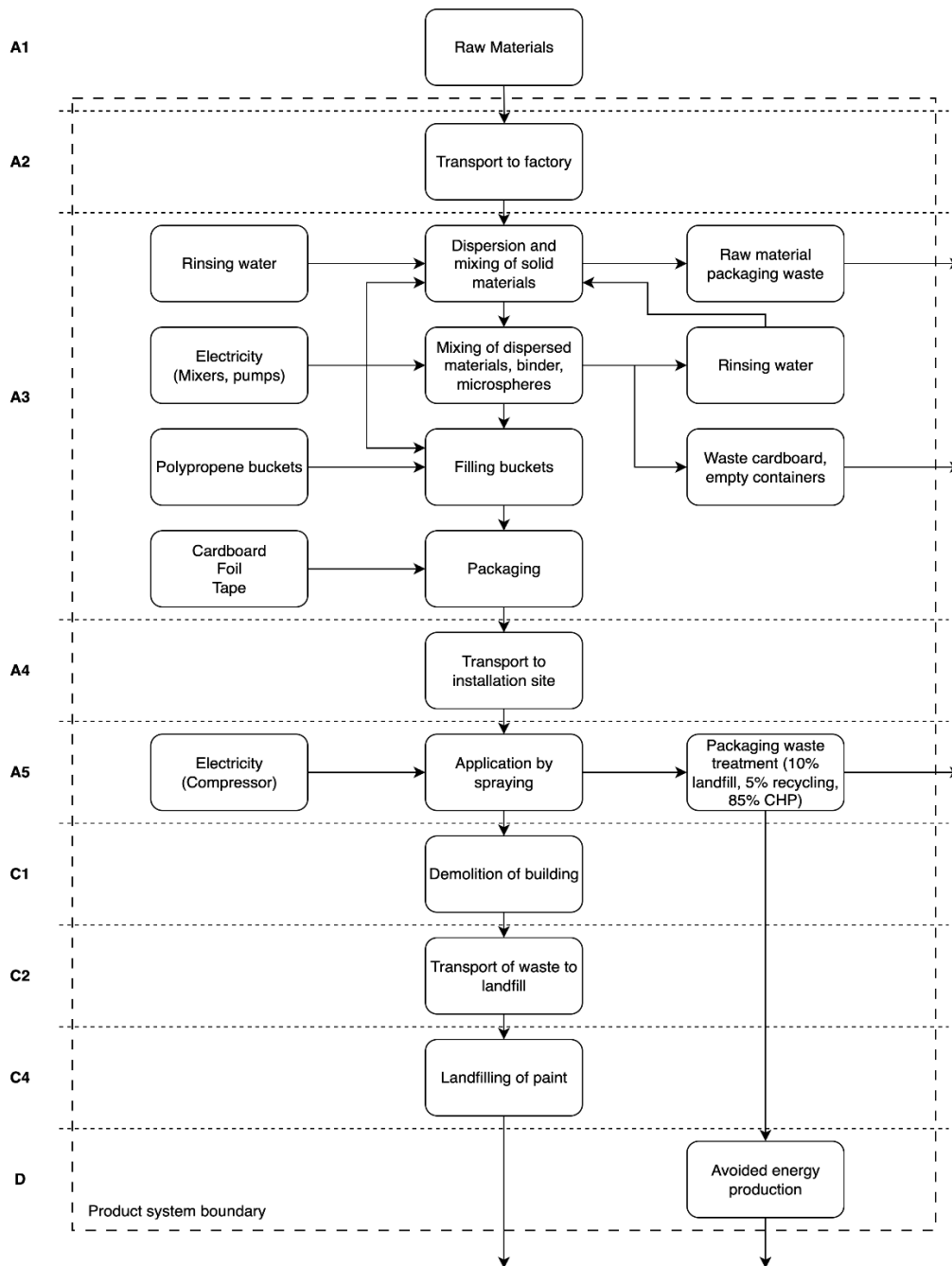

CALCULATION RULES

All relevant inputs and outputs - like emissions, energy and materials - have been considered in this LCA. In accordance with EN15804+A2, the total neglected input flows per module do not exceed 5% of energy usage and mass. Production loss inside the SICC plant was modelled based on emissions to air. Emissions to air in A3 were added to needed A1 raw materials. Data arises from SICC. Other data arises from standard values (for A4, C, D) in Dutch norm 'Bepalingsmethode 1.2'. Client data collection period was 2023. No allocation was done. A worst-case proxy of a pigment representative for all colours was made by using the percentages of hazardous constituents from the safety data sheets of every colour of pigment. Some colours contain other hazardous materials than others. The SDS's only provide the amounts of hazardous material in a percentage range. For every material, the highest value within the range is used. The percentage of each unique constituent was summed, with a total content of 98,05% of hazardous constituents. The remaining 1,95% is filled in with a generic reference for inorganic chemicals (filler is inorganic), to obtain a model where 100% of the contents of the pigment is specified, even though none of the pigments contain 100% hazardous materials. For this reason it is justified this proxy is a representative worst-case to be used for all colours.

SCENARIOS AND ADDITIONAL TECHNICAL INFORMATION

Within A1-A3, the following processes are included: Raw material production. Transport of raw materials to manufacturing location. Transport of ingredients to manufacturing location. Packaging production and transport. For A4, a distance of 663km was assumed (Berlin, Utrecht). C and D values are taken from EoL scenarios shown in table 1.
