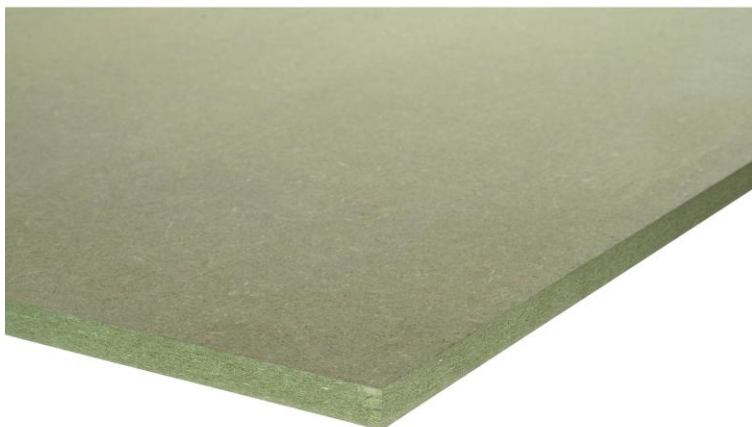

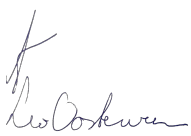
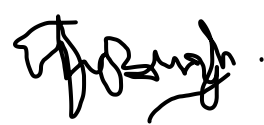

DETAILED PRODUCT DESCRIPTION

This EPD is a market average of medium-density fibreboard moisture resistant produced in Europe.

The production process starts with the debarking and chipping of the logs. Often wood from first thinning (smaller or uneven logs) are used for the production of fibre boards. The chips are grinded into even smaller parts: fibers. For the fibers to stick to each other, adhesives, wax and other additives are added. The coated fibers are then dried. The dried fibers are dispersed into a thick layer, which is then pressed together. After the fibers are pressed together, the board that is formed is cooled down. The last step in the production is sanding, cutting, and trimming the boards to size.

The RSL is 100 years for indoor applications, for other applications it is 75 years.

SCOPE AND TYPE

The dataset is an average EPD for medium-density fiberboard moisture resistant. It is transported, installed and disposed of in the Netherlands. The scope of the EPD is cradle-to-grave and module D.

This EPD is according to the NMD Assessment Method version 1.2 [1]. This document describes a standard operating procedure for drawing up an LCA of a Dutch construction product, in addition to the NEN EN15804 [2], ISO 14040 [3], ISO 14044 [4] and ISO14025 [5].

For this study, background data for the EN15804+A1 results are from the ecoinvent 3.6 database, released on 12 September 2019. The results are characterised with the EF 3.0 method.

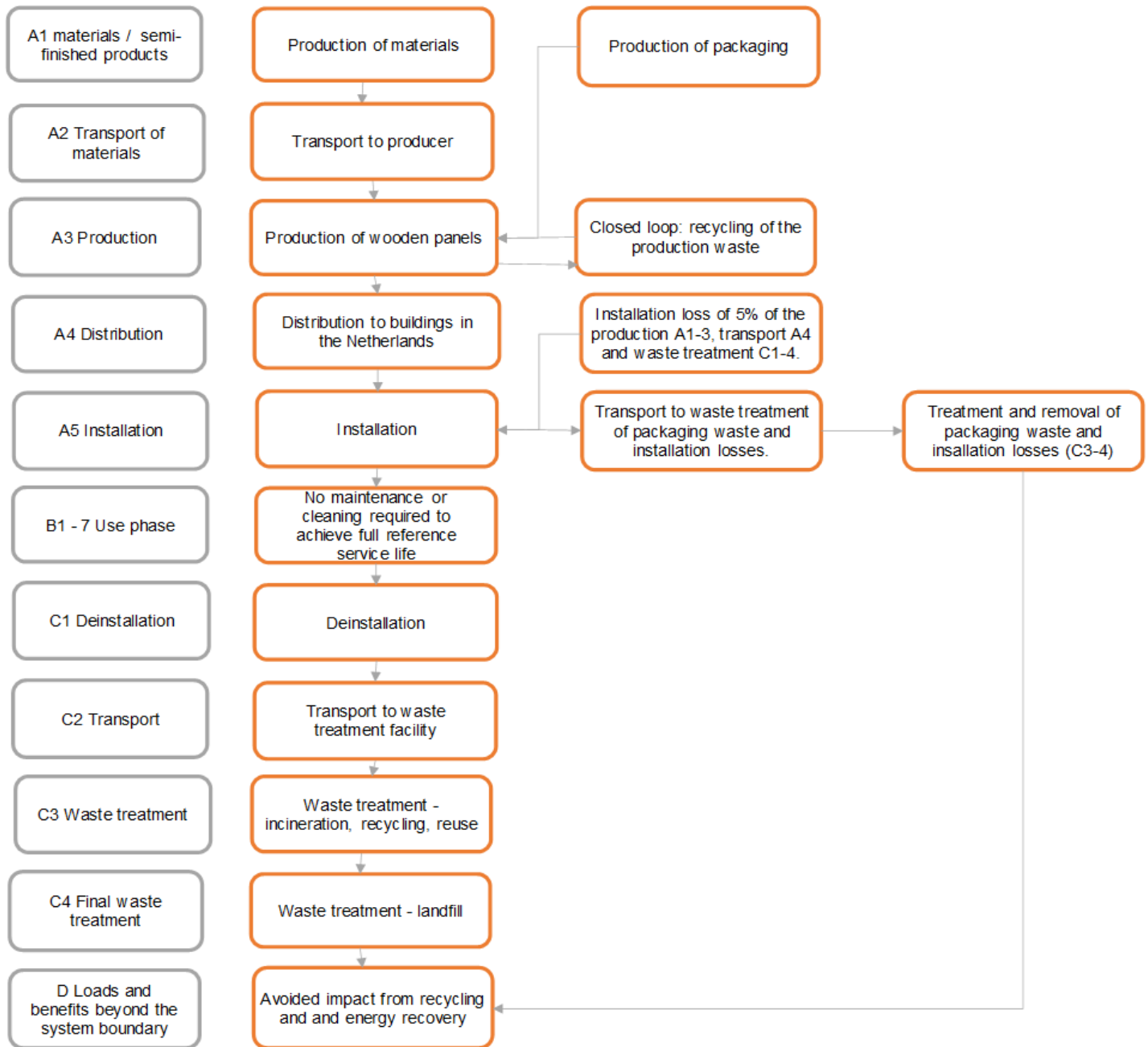
The EN15804+A2 results are from the ecoinvent 3.9.1 database, released on 15 December 2022. The results are characterised with the EF 3.1.

LCA software SimaPro 10.2.0.2 has been used.

REPRESENTATIVENESS

The EPD is representative for European medium-density fiberboard moisture resistant of the Dutch market. A representative market coverage has been achieved in line with the requirements of NMD Assessment Method v1.2. When needed, worst-case assumptions have been made to complement production data.

The production process differs little between manufacturers. The main variations are found in the types of adhesives used, wood species, and minor differences in composition and density of the panels. At least one producer from each major geographical region in Europe and several different wood species are included.

Input and output data have been provided by producers of the past 5 years for the following categories of data:

- Materials (raw materials and auxiliary materials);
- Energy (electricity and heat);
- Emissions to air, water and soil.

Waste and other economic flows have also been included in the data collection.

This LCA contains all relevant data, cut-off by classification is followed. The following processes are not included in this LCA:

- Assumed is that the maintenance and use of auxiliary equipment have a negligible contribution to the total (<1%). Because of this, these processes are not taken in account in this LCA, except such processes that are included in the ecoinvent background data.
- Assumed is that the capital goods and infrastructure processes have a negligible contribution. These processes are not taken in account in this LCA, except such processes that are included in the ecoinvent background data.

There is no reason to believe that relevant in- or outputs are excluded from this study.

The EPD follows a market-based approach on electricity modelling. Residual electricity mixes are used when available.

SCENARIOS AND ADDITIONAL TECHNICAL INFORMATION

A1. Supply of raw materials

This module declares the sourcing and processing of all raw materials and energy that take place upstream of the production process. Materials used in the production were modeled using the ecoinvent database and data from producers.

A2. Transportation of raw materials to manufacturer

This includes the transport distance of the raw materials to production facilities.

A3. Production

This module covers the production process and includes all processes related to production. The use of energy, the generation of waste, and direct emissions from the production process are taken into account.

A4. Transport to project location

The products are transported to the project location by truck. Because these locations are located throughout the country (the Netherlands), the transport is from production locations to Utrecht.

A5. Construction and installation process

This module processes the packaging waste and includes the installation. Installation losses of 5% are considered, which is in line with the default value of NMD Assessment Method.

Depending on the application and the size of the project, machinery may be used to transport and lift the product on the project site. Given the large number of possibilities, a worst-case scenario is assumed in which a diesel powered wheel loader is used for 5 minutes. Average fuel consumption of 13,54 liter per hour for a wheel loader is considered [6].

B1-7. Usage phase

The product as assessed for this EPD does not require any maintenance during the use phase.

C1. De-construction demolition

The product uninstallation process is the same as the installation of the product: diesel powered wheel loader is used for 5 minutes.

C2. Transport to waste processing

This module includes transportation to the waste treatment facility. Default distances for transportation per truck from the NMD Assessment Method are used. In the end of life scenario, the new waste scenario of the NMD for wood 'contaminated' is used [7].

C3. Waste management

In the end-of-life stage the products are partly incinerated, sent to landfill, recycled and reused.

C4. Final waste processing

Includes the final waste processing by means of landfill.

D. Income and expenditure beyond the system boundaries

In module D, the avoided production of material through recycling and avoided production of electricity and heat through incineration are included in this module. The material that is recycled is believed to replace wood chips.

The material that is incinerated is based on the lower calorific value of the material and the average efficiency of waste incineration plants in the Netherlands, namely 18% electricity and 31% heat. For the avoided energy consumption, a distinction is made between energy from biomass and fossil raw materials. The processes of NMD Assessment Method are used for avoided energy production.

The reused material is modelled as avoided A1-A3 production (excluding biogenic carbon uptake).

DECLARATION OF SVHC

No substances of very high concern are present in concentrations greater than 0,1% by weight in the product.
